# Safety Net Request for Proposals

Greater Cincinnati Foundation (GCF) invites your organization to partner with us to create a Greater Cincinnati where every person has a fair opportunity to thrive.

Our role is to connect generous donors with trusted nonprofits to create a vibrant region. One of the many ways we support our nonprofit partners is by offering competitive grants that align with our donors' interest areas. Funding in these areas is made available through our Request for Proposal (RFP) process.

This year GCF plans to distribute more than \$3 million across our RFPs. For the 2024 Safety Net cycle, GCF has approximately \$800,000 available and grants will be awarded for up to \$50,000. To be considered for funding, a Letter of Intent must be submitted by Friday, July 26, 2024, at 5:00 p.m.

# **Funding Focus**

Letters of Intent should explicitly address the following purpose:

Ensure that all people in our region have access to food, shelter, as well as increased access to well-integrated, trauma-informed mental and behavioral health services.

#### Use of Funds

Funding may be used to support, expand, or strengthen existing programs, enact capital improvements, launch a new program, or build organizational capacity. Collaboration between well-aligned organizations is highly favored. <u>Funding will not be awarded for campaigns or special events.</u> For more specifics of what funding may be used for, please review our Grant FAQs at <u>www.gcfdn.org/FAQ</u>.





#### Criteria

- o Applicants must be classified as tax-exempt by the IRS, typically 501(c)(3) status or government agency. If your organization is not a 501(c)(3), you may utilize a fiscal agent, however, the fiscal agent must be identified in the application.
- o Grants will be made to organizations with efforts based in the Greater Cincinnati region, which includes the counties of Hamilton, Butler, Warren, and Clermont in Ohio; Boone, Kenton, and Campbell in Kentucky and Dearborn in Indiana.
- Organizations meeting the above criteria are welcome to apply, however, preference will be given to:
  - o Organizations that develop solutions with a racial equity lens.
  - o Proposals with clear and measurable outcomes.
  - o Organizations that have demonstrated partnerships, collaboration, and alignment with community-wide efforts.
  - o Organizations that have demonstrated insights from their past results.
  - o Organizations using an asset-based approach to the work.

#### **Submission Process**

Respond to this RFP at <a href="www.gcfdn.org/Foundant">www.gcfdn.org/Foundant</a> using the "GCF Responsive Application." After creating a new account and/or logging in, complete the Letter of Intent (LOI) and submit it by Friday, July 26, 2024, at 5:00pm (EST).

If your organization's LOI is selected, you will be invited to submit an application. As part of this next step, applicants will be required to provide within the application and/or submit the following information:

- Most recent audit or 990
- Organizational demographics
- Project budget
- Income statement and balance sheet (Most recent two years, if possible)





Templates are provided for the project budget, income statement, balance sheet and organizational demographics. The use of these templates is optional.
