# **Boots on the Ground Fund**Request for Proposals

Greater Cincinnati Foundation (GCF) is pleased to announce the next round of *Boots on the Ground Fund* grants in its continued efforts to strengthen the capacity of small, community-based organizations driving change in our city. Through a partnership with the City of Cincinnati and generous support from other funders, more than \$750,000 will be made available for grants, up to \$25,000. Proposals will be considered for small, grassroots organizations with operating budgets of less than \$1 million, that demonstrate the involvement of community members in their decision-making and give voices to those directly impacted by issues.

### **Funding Focus**

The *Boots on the Ground Fund* seeks to provide support to organizations that have demonstrated experience and aim to address:

- Homelessness Prevention and Access to Affordable Housing
- Access to Affordable, Healthy Foods Reduction of Food Deserts
- Access to Healthcare and Public Health
- Workforce Development
- Youth Development
- Youth Gun Violence Reduction and Prevention
- Mental and Behavioral Health, including Substance Use Services

The focus areas listed above are flexible and in response to community needs.

# **Use of Funds**

- Funding may be used to support, expand, or strengthen existing programs, launch a new program, or build organizational capacity. Collaboration between organizations is highly encouraged.
- Funding will not be awarded for campaigns, capital campaigns, or special events.

#### Criteria

 Applicants must be classified as tax-exempt by the IRS, typically 501(c)(3) status or government agency.





- o If the organization is not a 501(c)(3), a fiscal sponsor may be utilized. However, the fiscal sponsor must be identified in the application.
- Applicants must have an <u>annual operating budget of less than \$1 million</u>.
- Programs or projects must directly impact residents within the City of Cincinnati.
- Preference will be given for demonstrating:
  - o Prioritization of inclusion, community voice, and engaging leaders of color
  - Clear and measurable outcomes or SMART Goals
    - Specific, Measurable, Achievable, Realistic and Timebound
  - o Partnerships and alignment to community-wide efforts
  - Learnings from past experience
  - Asset-based approaches in the funding focus areas
- 2024 Boots on the Ground Fund grant recipients are not eligible to apply.

### **Application Process**

Apply to the *Boots on the Ground Fund* Request for Proposal through the GCF online grantmaking system, Foundant at <a href="www.gcfdn.org/Foundant">www.gcfdn.org/Foundant</a>. After creating a new account and/or logging in, select the "Boots on the Ground Application." Complete the application and submit it by 5:00 p.m. on Friday, February 7, 2025.

The following (3) three documents must be uploaded for the application to be considered complete:

- Project Budget
- Income statement and balance sheet / Organizational Budget (or most recent 990, if applicable)
- Board List

#### **Deadline**

To be considered for funding, proposals must be submitted **by Friday, February 7, 2025, at 5:00 p.m. EST.**
